Please confirm the eligibility of applicants by referring to "1. Eligibility for General Admissions" below. However, some programs have requirements depending on the selection method, so please check the application guideline carefully.

Those who fall under "B. Applicants who need to be screened for eligibility" may apply for the Screening of Eligibility (Note 1) before application, and may apply if their eligibility is approved as a result of the screening.

(Note 1) Screening of Eligibility means that the graduate school of the university will examine whether or not the applicant has academic ability equivalent or superior to that of a university graduate before the application.

1. Eligibility for General Admissions

Applicants to the Graduate School may apply to the Graduate School if they meet any of the following criteria.

A. Those who do not need to be screened for eligibility

- (1) Individuals who have graduated from a Japanese 4-year university or are expected to graduate by the end of March 2025.
- (2) Individuals who have been granted a bachelor's degree or are expected to be granted it by the end of March 2025.
- (3) Individuals who have completed a 16-year program of school education in a foreign country or who are expected to complete by the end of March 2025.
- (4) Individuals who, while residing in Japan, have completed or are expected to complete by the end of March 2025 a 16-year program of school education abroad, through correspondence courses.
- (5) Individuals who have completed or are expected to complete by the end of March 2025 a course of a foreign school designated as equivalent to a foreign university in Japan (a foreign university branch in Japan designated by the Minister of Education, Culture, Sports, Science and Technology).
- (6) Individuals who have granted or are expected to grant by the end of March 2025 a degree equivalent to a bachelor's degree by completing a course of not less than three years from a foreign university.

- (7) Individuals who have completed or are expected to complete by the end of March 2025 a postsecondary course of a designated special training college.
- (8) Individuals recognized by the Minister of Education, Culture, Sports, Science and Technology as having an ability equivalent or superior to a university graduate in what concerns the admission to a graduate program.

B. Applicants who need to be screened for eligibility

(9) Individuals who have reached 22 years of age or will reach 22 years of age by March 2025, who have been

admitted to the graduate school of the University with academic ability equivalent or superior to that of a university graduate through an individual admission eligibility screening conducted by the graduate school of the University.

- (10) Individuals who have been enrolled in a university for at least three years as of the end of March 2025 and who are recognized by the graduate school of the university as having earned the prescribed credits specified by the graduate school of the university with excellent grades.
- (11) Individuals who meet one of the following criteria as of the end of March 2025, and who is recognized by the graduate school of the University as having earned the prescribed credits specified by the graduate school of the University with excellent grades.
 - ① Those who have completed 15 years of schooling in a foreign country.
 - ② Those who have completed 15 years of formal education in a foreign country by completing correspondence courses offered by a foreign school in Japan.
